

MISS JESSIE BYNUM

Miss Jessie Bynum, age 68, passed away at her home in Scottsboro Thursday afternoon, April 22, 1943, after a long illness. The funeral was conducted at the residence Friday afternoon by her pastor, Rev. S. T. Kimbrough, of the First Methodist Church of Scottsboro, and burial was in the family plot in Cedar Hill cemetery in this city.

She is survived by a sister, Mrs. Pontiff J. Skelton, two brothers, H. J. Bynum and Albert Bynum, all of this city. She also leaves three nieces, Mrs. Lucy Hamilton Jordan, Coral Gables, Fla.; Miss Lucy Bynum, member of the faculty of Kingsport (Tenn.) High School; Miss Jessie Bynum, member of the faculty of Wesleyan College, Macon, Ga. The four nephews are Hugh Hamilton, Easley, S. C.; Andrew Hamilton, Lancaster, S.C., Sgt Hugh Otis Bynum, of the U. S. Army; Meredith Bynum, Long Island, Ala., and Lieut. Mark Scott Skelton, in the army at Camp Shelby, Miss. Three great-nephews are Charles Wilson, John Price and Robert Hugh Bynum, sons of Meredith Bynum of Long Island. The two great-nieces are Ann and Nancy Jordan, daughters of Mrs. Lucy H. Jordan of Coral Gables.

The deceased was the daughter of the late Mr. and Mrs. Hugh Bynum and a granddaughter of Mr. and Mrs. Robert Scott, who were founders of the present city of Scottsboro. Her family on both paternal and maternal sides have been vital factors in the progress of our city from its infancy and these connections still maintain influential leadership in our community and county. Miss Bynum had been a member of the Methodist church and an active supporter of its calls since early girlhood.

A great philosopher once said: "Only two know the truth about people—their God and their neighbor." And in writing of Miss Jessie Bynum and her life, this editor has this precious advantage of knowing her life and its virtues, for she was my mother's next door neighbor for 29 years, and my mother called her "a strong and loving arm on which to lean in times of stress and warm friendship ever true and watchful for something to do to make life better for others." Miss Jessie, after the death of her mother many years ago, took the responsibility of making a home and caring for her bachelor brother, Albert Bynum, and he more than any one will miss her tender care, even though others will feel the keenness of the sorrow. Miss Jessie had been ill for several years and at times it appeared that only super-human courage was all that kept her in this world. She knew patience in its greatest degree and in her devotion for those whom she loved and cherished, she found no task beyond the call of her strength. She was a kind, gentle and thoughtful lady, cultured and refined in her ways and talk and tolerant in her attitude for unfortunates. As a neighbor she was a sort of Rock of Ages in which one could always put trust and find it filled. But even a Rock itself must wear away with the ravages of time and the Master had given this good Christian woman her full allotment of years in which to labor and she had filled all of them with material for eternal reward.

Although the sympathy of the community goes out to all the family of the deceased, there is that especial pang of sorrow for the broken-hearted brother who for most of his life had depended upon this "big sister" to make his home for him and administer to his needs

Mrs. Lucy Bynum, Age 78, Passes Away

Scottsboro and community is in mourning because of the passing of one of our best loved women, Mrs. Lucy Bynum, who quietly laid aside her earthly role on last Sunday evening, Feb. 21st, 1925, and her spirit went winging its way into eternal peace. Mrs. Bynum had been complaining for about two weeks but the seriousness of her condition was not realized until just a few minutes before her death, and the news of her passing came as a great shock to even the most intimate friends.

Mrs. Bynum was 78 years of age and she could truly have claimed the title of being a living part of Scottsboro. Before her marriage to the late R. H. Bynum, she was Miss Lucy Scott, daughter of R. T. Scott, the founder of Scottsboro, and her beautiful Christian life had been spent here in the shadows of the mountains in the town her parents founded. She lived the life typifying the real Southern gentlewoman—Christianity, modesty, friendliness and charity being the standards she maintained each day of her life.

Mrs. Bynum was the last remaining member of the original Scott family. As a girl she was a belle of the struggling little village, as a wife and mother she aided her husband in building and making progress in the town, and in the evening of her life she saw her children, nieces and nephews carrying on the forward movement of progress and better citizenship. Truly Scottsboro has lost a woman who was a living part of the town's history—a good woman, a woman worthy of the sorrow caused by her passing and worthy of any tribute that could be paid her memory.

She is survived by two daughters, Miss Jessie, with whom she made her home, Mrs. P. J. Skelton, and three sons, H. O., C. H. and Albert Bynum, and many relatives among the prominent families of Scottsboro.

Mrs. Bynum was a loyal member of the local Episcopal Church and the funeral was conducted at the Bynum home Wednesday afternoon, the Rev. Cary G. G. of Huntsville, conducting the service, after which she was tenderly laid to rest in the Cedar Hill cemetery beside her husband who died in 1909, and her children who had preceded her. The grave was hidden under a mountain of flowers tokening in a small part the esteem in which she was held by her neighbors, friends and acquaintances in her native home.

To the heart-broken children, grandchildren and relatives the sympathy of the people goes out in this dark hour.

We the undersigned Commissioners, by virtue of the accompanying Commission made and directed to us, by your Honor, authorising, empowering and directing us to partition and allot certain lands belonging to the estate of Robert T. All of the foregoing land having been surveyed, the lines in
most instances will be defined by marks upon the trees, and
corners set up, we deem it unnecessary to describe them more
minutely, and further the name of the drawer marked upon the

Said lots of land so numbered we then placed on separate
ballots in a hat, as also the names of said heirs (to wit) Mary

and after having drawn as before we found that they had
drawn as follows, (ie) that Anna Scott had drawn the E. 1/4 of the
N. 1/4 of section No 30. not included in town lots, also all of the S. E. 1/4
of the S. 1/4 ^{of section No 19, not} included in the town, of Cottisboro. that Warran Scott
had drawn the E. 1/2 of the S. E. 1/4 of section No 30 and that Forrest Scott
had drawn the S. 1/2 of the S. 1/4 of section No 29, and that part
of the N. 1/4 of the S. E. 1/4 & S. 1/4 of N. E. 1/4 of section No 19, marked





1. Moderate drinking tends to drunkenness, while total abstinence directly from it.
2. While no one means to become a drunkard, there is said to be over six hundred thousand confirmed drunkards in our country to-day.

11. Persons miscalculate their ability to drink in moderation, and become slaves to the drinking habit before they are aware of it.
12. Intemperance obstructs civilization, education, religion and every useful reform.
